THE PARTICIPANT AGREES WITH THE FOLLOWING RULES, TERMS, & CONDITIONS:

The participant agrees to abide by the rules of Coastlife Mobile Laser Skirmish at all times while present at the venue.

- 1- No rocks or other debris are to be thrown, kicked or otherwise to be made airborne by participants.
- 2- No participant shall engage in any of the following:
 - a- Reckless or foolish behaviour.
 - b- Any behaviour likely to cause injury to themselves or other participants.
 - c- Any behaviour likely to cause injury to the employees or agents of Coastlife Mobile Laser Skirmish.
 - d- Any other behaviour deemed unacceptable by Coastlife Mobile Laser Skirmish.
 - e- Any behaviour likely to cause damage to the equipment or property of Coastlife Mobile Laser Skirmish, its agents, or landowner.
- 3- Coastlife Mobile Laser Skirmish may require any participant engaging in unacceptable behaviour to leave the Coastlife venue.
- 4- Each participant must remain within the designated boundaries of the Coastlife venue at all times.
- 5- Each participant will be required to wear the following:
 - a- long pants covering the entire leg.
 - b- Enclosed shoes protecting the toes.
 - c- Any other safety devices that may be required by Coastlife Mobile Laser Skirmish.
- 6- Any participant that refuses or is unable to comply with these rules will not be permitted to participate.
- 7- All participants must follow the directives of the staff of Coastlife Mobile Laser Skirmish at all times.
- 8- Any participant that is injured, or observing another player injured, shall immediately notify the staff of Coastlife Mobile Laser Skirmish of the incident.

RELEASE & DISCHARGE

The participant releases, discharges, waives and forever holds harmless Coastlife Mobile Laser Skirmish for all claims for any loss or injuries sustained by the participant whether caused by negligent act or wilful act or omission, breach of contract, breach of statutory duty or otherwise in connection with Coastlife Mobile Laser Skirmish. The participant agrees to Coastlife Mobile Laser Skirmish taking photographs or other images while participants are at the venue and to develop, reproduce and use them royalty free for any purpose (including commercial advertising).

WARRANTY AS OF AGE

By personally executing this deed, the participant warrants that he or she is at least eighteen (18) years of age. Where this deed is executed by a parent, guardian, or other person for and on behalf of the participant,

that is under the age of 18 years, the person so executing warrants that he or he has the authority to do so and agrees to indemnify Coastlife Mobile Laser Skirmish in terms contained in Release & Discharge clause.

BAR TO ACTION

The participant agrees that this deed may be pleaded as a bar to any action, suit or proceedings taken at any time by the participant against Coastlife Mobile Laser Skirmish arising out of or as a consequence of Coastlife Mobile Laser Skirmish or any incidental activities.

PRIVACY

Coastlife Mobile Laser Skirmish collects information from you for the primary purpose of providing quality indoor/outdoor Laser Skirmish entertainment. We require you to provide us with details so that we may properly attend to your needs. This means that we will use the information you provide in the following ways: administrative purposes, billing purposes (if required), disclosure for research and quality assurance activities to improve entertainment services, and if needed, emergency situations whereby staff/hospitals require access to a participants records for appropriate purposes.

DEFINITIONS

In this deed unless inconsistent with the context or subject matter: All Claims referring to all claims, actions, suits, demands, damages, interest and costs arising out of or as consequence of Coastlife Mobile Laser Skirmish, including any incidental activity. Any Loss refers to any loss, damage or injury to person (including the participant) or property including but not limited to:

- (a) Any damage or injury occasioned to a participant, howsoever by:
 - 1- Any logs, trees, branches or any part thereof.
 - 2- Any rocks, falling boulders, or stones.
 - 3- Any rivers, creeks, streams, or any other body of water existing at a Coastlife venue.
 - 4- Any snakes, spiders, or any other wildlife whatsoever.
 - 5- Other participants
 - 6- Any equipment supplied to the participant by Coastlife Mobile Laser Skirmish in connection with Laser Skirmish.
 - 7- Or otherwise arising out of the participant's involvement in Laser Skirmish.
- (b) Any damage or injury occasioned to a participant as a result of a participant (however caused):
 - 1- Slipping on rocks, boulders, logs, trees, land, or any other substance.
 - 2- Falling over.
 - 3- Colliding with another participant.

"Laser Skirmish" refers to the indoor/outdoor action combat game run by Coastlife Mobile Laser Skirmish.

"Coastlife Venue" refers to the location at which the Laser Skirmish game is being convened.

"Participant" refers to the person whose name appears on this form.
